23 credibility of the job estimates;

24 (b) The board shall also consider the need for job creation based
25 on the unemployment rate of the county or counties in which the project
26 is located. In evaluating the average wages of the jobs created, the
27 board shall compare those wages to median wages of private sector jobs
28 in the county or counties surrounding the project location;

29 (c) When evaluating the jobs created by the project, the board may
30 consider the area labor supply and readily available skill sets of the
31 labor pool in the county or counties surrounding the project location;

32 (d) How the expected business creation or expansion fits within the
33 region's preferred economic growth strategy as indicated by the efforts
34 of nearby innovation partnership zones, industry clusters as defined by
35 the Washington Economic Development Commission, future export
36 prospects, or local government equivalent if available;

37 (e) The speed with which the project can begin construction;

1 (f) The extent that the final list of grant awards provides broad
2 geographic distribution, leverages nonstate funds, and achieves overall
3 the greatest benefit in job creation at good wages for the amount of
4 money provided;

5 (g) In no event shall the board award a grant that supplants
6 previously committed project resources.

7 (3) The board shall prioritize community revitalization grants by
8 considering at a minimum the following criteria:

9 (a) The value of the project to the community. In evaluating the
10 value of the project, the board shall, at a minimum, consider the
11 difficulty the applicant has in financing main street improvement
12 projects with their own local resources and the extent the project will
13 increase economic activity for existing businesses, improve safety and
14 enjoyment of pedestrians and bicyclists, enhance in-city recreational
15 opportunities, and revitalize downtown business districts.

16 (b) The extent to which businesses and local governments in the
17 affected area support the project;

18 (c) Whether or not the project is in the local government's adopted
19 capital facility plan, comprehensive plan, or equivalent. Additional
20 consideration is given to projects located within one of the
21 aforementioned plans;

22 (d) The extent to which the project promotes infill and
23 redevelopment of the downtown area;

24 (e) The speed with which the project can begin construction;

25 (f) The extent that the final list of grant awards provides broad
26 geographic distribution, leverages nonstate funds, and achieves overall

- 12 (vi) State government programs for the safe reduction, recycling,
13 or disposal of hazardous wastes from households, small businesses, and
14 agriculture;
- 15 (vii) Hazardous materials emergency response training;
- 16 (viii) Water and environmental health protection and monitoring
17 programs;
- 18 (ix) Programs authorized under chapter 70.146 RCW;
- 19 (x) A public participation program, including regional citizen
20 advisory committees;
- 21 (xi) Public funding to assist potentially liable persons to pay for
22 the costs of remedial action in compliance with cleanup standards under
23 RCW 70.105D.030(2)(e) but only when the amount and terms of such
24 funding are established under a settlement agreement under RCW
25 70.105D.040(4) and when the director has found that the funding will
26 achieve both (A) a substantially more expeditious or enhanced cleanup
27 than would otherwise occur, and (B) the prevention or mitigation of
28 unfair economic hardship;
- 29 (xii) Development and demonstration of alternative management
30 technologies designed to carry out the hazardous waste management
31 priorities of RCW 70.105.150;
- 32 (xiii) During the 2009-2011 and 2011-2013 fiscal biennia, shoreline
33 update technical assistance;
- 34 (xiv) During the 2009-2011 fiscal biennium, multijurisdictional
35 permitting teams; and
- 36 (xv) During the 2011-2013 fiscal biennium, actions for reducing
37 public exposure to toxic air pollution, and actions taken through the

1 family forest fish passage program to correct barriers to fish passage
2 on privately owned small forest lands.

3 (3) The following moneys shall be deposited into the local toxics
4 control account: Those revenues which are raised by the tax imposed
5 under RCW 82.21.030 and which are attributable to that portion of the
6 rate equal to thirty-seven one-hundredths of one percent.

7 (a) Moneys deposited in the local toxics control account shall be
8 used by the department for grants or loans to local governments for the
9 following purposes in descending order of priority:

10 (i) Remedial actions;
11 (ii) Hazardous waste plans and programs under chapter 70.105 RCW;
12 (iii) Solid waste plans and programs under chapters 70.95, 70.95C,
13 70.95I, and 70.105 RCW;

14 (iv) Funds for a program to assist in the assessment and cleanup of
15 sites of methamphetamine production, but not to be used for the initial
16 containment of such sites, consistent with the responsibilities and
17 intent of RCW 69.50.511; and

18 (v) Cleanup and disposal of hazardous substances from abandoned or
19 derelict vessels, defined for the purposes of this section as vessels
20 that have little or no value and either have no identified owner or
21 have an identified owner lacking financial resources to clean up and
22 dispose of the vessel, that pose a threat to human health or the
23 environment.

24 (b) Funds for plans and programs shall be allocated consistent with
25 the priorities and matching requirements established in chapters
26 70.105, 70.95C, 70.95I, and 70.95 RCW, except that any applicant that
27 is a Puget Sound partner, as defined in RCW 90.71.010, along with any
28 project that is referenced in the action agenda developed by the Puget
29 Sound partnership under RCW 90.71.310, shall, except as conditioned by
30 RCW 70.105D.120, receive priority for any available funding for any
31 grant or funding programs or sources that use a competitive bidding
32 process. During the 2007-2009 fiscal biennium, moneys in the account
33 may also be used for grants to local governments to retrofit public
34 sector diesel equipment and for storm water planning and implementation
35 activities.

36 (c) To expedite cleanups throughout the state, the department shall
37 partner with local communities and liable parties for cleanups. The

1 department is authorized to use the following additional strategies in
2 order to ensure a healthful environment for future generations:

3 (i) The director may alter grant-matching requirements to create
4 incentives for local governments to expedite cleanups when one of the
5 following conditions exists:

6 (A) Funding would prevent or mitigate unfair economic hardship
7 imposed by the clean-up liability;

8 (B) Funding would create new substantial economic development,
9 public recreational, or habitat restoration opportunities that would
10 not otherwise occur; or

11 (C) Funding would create an opportunity for acquisition and
12 redevelopment of vacant, orphaned, or abandoned property under RCW
13 70.105D.040(5) that would not otherwise occur;

14 (ii) The use of outside contracts to conduct necessary studies;

15 (iii) The purchase of remedial action cost-cap insurance, when
16 necessary to expedite multiparty clean-up efforts.

17 (d) To facilitate and expedite cleanups using funds from the local
18 toxics control account, during the 2009-2011 fiscal biennium the
19 director may establish grant-funded accounts to hold and disperse local
20 toxics control account funds and funds from local governments to be
21 used for remedial actions.

23 43.79.282, moneys in the state and local toxics control accounts may be

13 natural resource lands at risk of development, the department, with
14 approval of the board of natural resources, may exchange any state land

22 transaction. These administrative expenses include road maintenance
23 and abandonment expenses. The amount of proceeds received from the
24 exchange partner may not exceed five percent of the total value of the
25 exchange. The receipt of proceeds shall not change the character of
26 the transaction from an exchange to a sale.

34 critical habitat purposes.

35 **Sec. 6007.** RCW 79.17.020 and 2009 c 497 s 6025 are each amended to
36 read as follows:

37 (1) The board of county commissioners of any county and/or the

1 mayor and city council or city commission of any city or town and/or
2 the board shall have authority to exchange, each with the other, or
3 with the federal forest service, the federal government or any proper
4 agency thereof and/or with any private landowner, county land of any
5 character, land owned by municipalities of any character, and state
6 forest land owned by the state under the jurisdiction of the
7 department, for real property of equal value for the purpose of
8 consolidating and blocking up the respective land holdings of any
9 county, municipality, the federal government, or the state of
10 Washington or for the purpose of obtaining lands having commercial
11 recreational leasing potential.

12 (2) During the biennium ending June 30, ((2011)) 2013, for the
13 purposes of maintaining working farm and forest landscapes or acquiring
14 natural resource lands at risk of development, the department, with
15 approval of the board of natural resources, may exchange any state land
16 and any timber thereon for any land and proceeds of equal value, when
17 it can be demonstrated that the trust fiduciary obligations can be
18 better fulfilled after an exchange is completed. Proceeds may be in
19 the form of cash or services in order to achieve the purposes
20 established in this section. Any cash received as part of an exchange
21 transaction shall be deposited in the forest development account to pay
22 for administrative expenses incurred in carrying out an exchange
23 transaction. These administrative expenses include road maintenance
and abandonment expenses. The amount of proceeds received from the
25 exchange partner may not exceed five percent of the total value of the
26 exchange. The receipt of proceeds shall not change the character of
27 the transaction from an exchange to a sale.

28 (3) Prior to executing an exchange under this section, and in
29 addition to the public notice requirements set forth in RCW 79.17.050,
30 the department shall consult with legislative members, other state and
31 federal agencies, local governments, tribes, local stakeholders,
32 conservation groups, and any other interested parties to identify and
33 address cultural resource issues, and the potential of the state lands
34 proposed for exchange to be used for open space, park, school, or
35 critical habitat purposes.

36 **Sec. 6008.** RCW 79.105.150 and 2011 2nd sp.s. c 9 s 6009 are each
37 amended to read as follows:

1 (1) After deduction for management costs as provided in RCW
2 79.64.040 and payments to towns under RCW 79.115.150(2), all moneys
3 received by the state from the sale or lease of state-owned aquatic
4 lands and from the sale of valuable material from state-owned aquatic
5 lands shall be deposited in the aquatic lands enhancement account which
6 is hereby created in the state treasury. After appropriation, these
7 funds shall be used solely for aquatic lands enhancement projects; for
8 the purchase, improvement, or protection of aquatic lands for public
9 purposes; for providing and improving access to the lands; and for
10 volunteer cooperative fish and game projects. During the 2009-2011 and
11 2011-2013 fiscal biennia, the aquatic lands enhancement account may
12 also be used for scientific research as part of the adaptive management
13 process and for developing a planning report for McNeil Island. During
14 the 2009-2011 and 2011-2013 fiscal biennia, the legislature may
15 transfer from the aquatic lands enhancement account to the state
16 general fund such amounts as reflect excess fund balance of the
17 account. During the 2011-2013 fiscal biennium, the aquatic lands
18 enhancement account may be used to support the shellfish program, the
19 ballast water program, and the Puget Sound toxic sampling program at
20 the department of fish and wildlife, ((and)) the knotweed program at
21 the department of agriculture, and the Puget SoundCorps program.

22 (2) In providing grants for aquatic lands enhancement projects, the
23 recreation and conservation funding board shall:

24 (a) Require grant recipients to incorporate the environmental
25 benefits of the project into their grant applications;

26 (b) Utilize the statement of environmental benefits, consideration,
27 except as provided in RCW 79.105.610, of whether the applicant is a
28 Puget Sound partner, as defined in RCW 90.71.010, whether a project is
29 referenced in the action agenda developed by the Puget Sound
30 partnership under RCW 90.71.310, and except as otherwise provided in
31 RCW 79.105.630, and effective one calendar year following the
32 development and statewide availability of model evergreen community
33 management plans and ordinances under RCW 35.105.050, whether the
34 applicant is an entity that has been recognized, and what gradation of
35 recognition was received, in the evergreen community recognition
36 program created in RCW 35.105.030 in its prioritization and selection
37 process; and

1 (c) Develop appropriate outcome-focused performance measures to be
2 used both for management and performance assessment of the grants.

3 (3) To the extent possible, the department should coordinate its
4 performance measure system with other natural resource-related agencies
5 as defined in RCW 43.41.270.

6 (4) The department shall consult with affected interest groups in
7 implementing this section.

8 (5) After January 1, 2010, any project designed to address the
9 restoration of Puget Sound may be funded under this chapter only if the
10 project is not in conflict with the action agenda developed by the
11 Puget Sound partnership under RCW 90.71.310.

12 **NEW SECTION. Sec. 6009. FOR THE STATE TREASURER--TRANSFERS**

13 State Taxable Building Construction Account: For transfer to the
14 Columbia River Basin Taxable Bond Water Supply Development Account, an
15 amount not to exceed \$10,404,000.

16 **NEW SECTION. Sec. 6010.** A new section is added to 2011 1st sp.s.
17 c 49 (uncodified) to read as follows:

18 **NONTAXABLE AND TAXABLE BOND PROCEEDS**

19 Portions of the appropriation authority granted by this act from
20 the state building construction account, or any other account receiving
21 bond proceeds, may be transferred to the state taxable building
22 construction account as deemed necessary by the state finance committee
23 to comply with the federal internal revenue service rules and
24 regulations pertaining to the use of nontaxable bond proceeds.
25 Portions of the general obligation bond proceeds authorized by chapter
26 49, Laws of 2011 1st sp. sess. for deposit into the state taxable
27 building construction account that are in excess of amounts required to
28 comply with the federal internal revenue service rules and regulations
29 shall be deposited into the state building construction account. The
30 state treasurer shall submit written notification to the director of
31 financial management if it is determined that a shift of appropriation
32 authority between the state building construction account, or any other
33 account receiving bond proceeds, and the state taxable building
34 construction account is necessary, or that a shift of appropriation
35 authority from the state taxable building construction account to the
36 state building construction account may be made.

1 NEW SECTION. **Sec. 6011.** The office of financial management, in
2 consultation with the legislative fiscal committees, shall choose a
3 consultant to identify and evaluate options for the efficient and cost-
4 effective incarceration by the department of corrections of adult
5 prison offenders forecasted over the next ten years. Options to be
6 evaluated must include, but are not limited to: (1) Construction of
7 one or more new prisons; (2) construction of new prison units at
8 existing facilities; (3) replacement, remodeling, or repurposing of
9 existing, aged, inefficient capacity; and (4) management and use of
10 emergency beds. The study must include, for each option, the estimated
11 capital, operating, and debt service costs for the next ten years. The
12 study must also discuss the risks, advantages, and disadvantages of
13 each option. In addition, the department must identify all emergency
14 beds, their current status, and the cost to bring on-line and operate
15 any currently empty emergency beds and projected needs. The report
16 must be submitted to the governor and the fiscal committees of the
17 legislature no later than October 1, 2012.

18 NEW SECTION. **Sec. 6012.** If any provision of this act or its
19 application to any person or circumstance is held invalid, the
20 remainder of the act or the application of the provision to other
21 persons or circumstances is not affected.

22 NEW SECTION. **Sec. 6013.** This act is necessary for the immediate
23 preservation of the public peace, health, or safety, or support of the
24 state government and its existing public institutions, and takes effect
25 immediately.
